Minor Projects can help to boost skills, widen the horizon of thinking amongst faculties & students and equip them for taking up challenging research activities in future career.

All the project proposals submitted by the MBB University faculty members from different postgraduate departments will be placed before Expert committee constituted by MBB University for evaluation. MBB University will grant a financial assistance of Rs. 15,000/- (Rupees Fifteen Thousand) per minor project subject after final evaluation and recommendation of the Expert Committee.

Areas of Minor Projects

The project should aim at improving at mid and long term the physical, social and economic conditions of the students of Tripura in addition to their short term/immediate need. The proposal should be specifically aimed at improving the education system of students of Tripura using novel/innovative technologies. Projects should focus on Indigenous Knowledge System strengthening pertinent to education system of Tripura.

Guidelines for Contributors

Proposals should contain the following sections:

1. A cover sheet with the project's title and names, institutional affiliations, and contact information of all Principal Investigators and Co-investigators.
2. Explanation of the motivation for the proposed activities. This section should address:
 - The scientific and/or methodological merit of the proposed project.
 - The objectives of the proposed project.
 - The objectives should clearly demonstrate the project's potential to create positive developmental impacts and/or social value.
3. Description of how the activities will be carried out, and anticipated outputs, outcomes, and impacts.
4. Identification of potential sources of the project will pursue.

1.3 The purpose of this MoU is to outline an academic and management framework between the Universities they do not intend to be legally bound to each other and this MoU does not impose any legal obligation on either party.

1.4 The undertaking of each activity to be carried out under the MoU will be subject to the availability of funds. Each University shall bear the expenses for its participation in the projects and activities to be carried out under this MoU.

2. COORDINATION COMMITTEE :

There will be Co-ordination Committee for effective execution of the activities to be carried out under this MoU and for reviewing their progress. The committee shall submit written report of the progress of the activities to be carried out under the MoU.

3. EFFECTIVE DATE AND DURATION OF THE MOU:

This MoU shall be effective from 09.02.2021 The duration of the MoU will be initially for a period of five years from the effective date.

4. AMENDMENT TO MOU :

No amendment to this MoU shall be valid unless the same is made in writing jointly by the parties hereto or their authorized representatives and specifically stating the same to be an amendment to this MoU.

5. TERMINATION OF MOU :

5.1 The MoU can be terminated by either party giving to the other party a prior written notice of not less than ninety days

1. **Research for Resurgence Foundation**, Sheshadri Sadan, Tulsibaug Road, Mahal, Nagpur, Maharashtra-440032 (Bharat) (Hereinafter referred as **RFR Foundation**) founded by voluntary organization Bharatiya Shikshan Mandal by or repugnant to the subject shall mean and include its successors and assigns.

AND

2. **Maharaja Bir Bikram University**, P.O. - Agartala College, College Tilla, Agartala, Dist: West Tripura - 799004, Tripura Agartala, Tripura, India (Bharat) (Hereinafter referred as **MBB University**) established by Maharaja Bir Bikram University Act, 2015 (Tripura Act No. 6 of 2015) of State Legislature.

RFR Foundation and **MBB University** are referred to individually as a “**Party**” and collectively as “**Parties**”. Both Parties have reached the following intent to collaboration as per below described articles of this MOU.

ARTICLE 1: BACKGROUND AND PURPOSE

- 1.1.1. Research for Resurgence Foundation is founded by voluntary organization Bharatiya Shikshan Mandal (hereinafter referred as RFR Foundation). The core objective of RFR Foundation is to bring paradigm shift in research outcome, research methodology and innovation-based technologies, ensuring Bharatiya prospective, philosophy and applicability.
- 1.1.2. The RFR Foundation has functional dimensions to strengthen and synchronize Research, Researchers, Resources and Reach.
- 1.1.3. The RFR Foundation is a multi-domain Research Institute and a network hub of research and allied activities in academics and industrial sector.

AND

- 1.2.1. Maharaja Bir Bikram University was established by Maharaja Bir Bikram University Act, 2015 (hereinafter referred as MBB University). It was established to provide higher education particularly up to Post Graduate and higher level, training and research in various branches of learning and courses of study.
- 1.2.2. MBB University has its core objective to disseminate an advance knowledge by providing instructional and research facilities in such branches of learning as it may deem fit and by the example of its corporate life and, in particular, to make special provisions for studies in tribal life and culture and for integrated courses of Humanities, Commerce, Rural Development & Management, Social and Basic Sciences, Medical Science and Engineering & Technology in the educational programmes of the University and take appropriate measures for promoting inter—disciplinary studies and research in the University. Being the highest and noblest seat of learning, the University shall provide effective leadership in guiding education and promoting research work in various fields and shall also

endeavour to promote study of vocational subjects with a view to providing more scope and opportunities of higher education to serve the society and the nation as well as employment opportunities to the students.

1.1 Purpose:

RFR Foundation and MBB University are interested in working together with mutual collaboration to give each other's strengths in research and facilities thereof, which will mutually benefit the students and faculties for nurturing the research, innovation and creativity among students. Now therefore the parties hereto have agreed to enter into a memorandum of understanding considering the long term benefits of sharing the knowledge and resources between the institute and establish a strong academic collaboration, by undertaking joint responsibilities and activities in their respective field of excellence, research, resources, knowledge and human described in the article 2 of this MOU as area of collaboration.

ARTICLE 2: AREAS OF COLLABORATION

The parties hereby agree to work collaboratively on following points for the effective and efficient engagement by fulfilling the purpose of this MoU towards strengthening and streamlining research in scientific and technology development, innovation and entrepreneurship ecosystem in Bharat. The mutually agreed **activities** by and between the parties are as under:

1. The responsibilities and work for MBB University:

- 1.1. Setting-up functional RFR Foundation extension centre in academic campus for
 - 1.1.1. Awareness, publicity & accessibility for RFR Foundation work, facilities and opportunities.
 - 1.1.2. Awareness, publicity & accessibility for research activities, programs, seminars, workshops, conferences are to be jointly organized.
 - 1.1.3. Philosophical acceptance and responsibility towards concept of 'Resurgence'.
 - 1.1.4. Monitoring, execution and evaluation of parameter/s of research applicability for nation / society / local requirement, incorporation of

Bharatiya methodology and references in various programs at institutional level including Ph.D., M.Phil., Post-Graduation, Under Graduation research projects and research methodology program.

- 1.1.5. Establishing platform for converting strength & excellence in terms of infrastructure and human resource for betterment of educational systems across world.
- 1.2. To organize national, international events, program at mutually agreed interval.
- 1.3. To provide infrastructure, academic & technical Support in various activities organized by RFR Foundation, subject to availability.
- 1.4. Promote and support student(s), faculty(s) exchange programs.
- 1.5. Maintain respect and dignity among other Academic associates and Industrial associates of RFR Foundation.
- 1.6. Active participation in associate members' annual meetings organized by RFR Foundation.
- 1.7. To recognize RFRF as workplace for research including Ph.D. studies and post-doctoral research.
- 1.8. To recognize RFRF faculties as adjunct faculties (Associate Professor, Professor) of the university.

2. The responsibilities and work for RFR Foundation:

- 2.1. To provide Title "Academic Associate"& its certification to.
- 2.2. To provide access to knowledge resource centre of RFR Foundation.
- 2.3. To facilitate MBB University for industry-academia, academia-academia collaborations at national & international level.
- 2.4. To provide support in conduction of Refresher Courses, Orientation courses, Research methodology programs and faculty development program.
- 2.5. Promotion of Research Activities in common interest area.
- 2.6. Privileged invitation for event(s) / program(s) organized by RFR Foundation and Bharatiya Shikshan Mandal (limited number of guests).
- 2.7. Display and information about facilities and opportunities at MBB University in the reception gallery at foundation.
- 2.8. Two nominations (incumbent authorities) in *Samanvay Sabha* for associates.



- 2.9. Support in execution, monitoring and evaluation process of various research activities.
- 2.10. Access and usage of knowledge resource centre, infrastructural facilities such as convention centre at special 'Academic Associates' discounted charges.
- 2.11. The facilities for students and faculties at concessional charges.
- 2.12. Consultation, unbiased evolution of various educational processes as RFR Foundation Academic & Administrative Audit program.
- 2.13. Information and invitation for research events conducted by other associate members for associates' network.

ARTICLE 3: CO-ORDINATION AND NODAL OFFICER

Both entities shall mutually decide and designate a nodal officer. The nodal officer will have responsibility for fulfilling the objectives of this agreement and also will carry out all activities mutually agreed by the parties.

ARTICLE 4: SCOPE

The Parties acknowledge and agree that the Areas of Collaboration are not exhaustive in nature and the Parties shall in good faith, negotiate to elaborate upon the Areas of Collaboration, including additional areas of collaboration as may be mutually agreed and the rights, responsibilities and obligations of each Party in relation to each of the Areas of Collaboration. The Parties may, from time to time, execute addenda or modifications to this MOU to incorporate such additional scope of collaboration or discussions in accordance with Clause 6.3.

ARTICLE 5: DURATION

This MOU shall be valid after its signature from the date of signing till for **FIVE** years. The Parties may further extend the MOU with mutual written consent, in order to ensure continuous inputs regarding in light of changing trends and environment in the area of collaboration for this MOU. As part of subsequent extensions, the Parties may agree to make amendment in the MOU.

ARTICLE 6: TERMS

6.1 Finance

Both Parties shall be responsible to carry out the activities under the area of collaboration and New Project, Program, Conference, Seminar, Workshop and like which is co-designed/ organized by both of the parties. The financial arrangements wherever involved will be decided and approved after mutual consent and shall be agreed to for each activity individually on resource deployment, arrangements and mobilization will be planned vis-a-vis.

6.2 Assignment

Neither of the Parties shall assign any of their duties under this MOU to any other person or institution without prior approval of other party. A specific agreement will be entered into for each activity.

6.3 Amendments

No alterations, additions or modification hereto shall be valid and binding unless the same are reduced to writing and signed by both the Parties.

6.4 Non-Exclusive Discussions

The Parties acknowledge and agree that the Areas of Collaboration under this MOU are being undertaken on a non-exclusive basis and either Party shall be free to enter into or consummate transactions similar to the Areas of Collaboration with other parties in Bharat or elsewhere.

6.5 Confidentiality and Public Announcement:

6.5.1. "Confidential Information" means the confidential, proprietary, and trade secret information of the disclosing party to be disclosed by the disclosing party under this MOU and comprises (a) information in tangible form that: (a) (1) bears a Confidentiality Legend, or (2) does not bear any Confidentiality Legend, if the receiving party knew, or reasonably should have known under the circumstances, that the information was confidential and had been communicated to it in confidence, and (b) discussions about

that information that may occur before, at the same time, or after disclosure of the information. This MOU and all confidential information exchanged between the Parties pursuant to this MOU shall be held in confidence.

6.5.2. Neither Party nor any of the affiliates shall make any public announcement about the MOU and /or the scope of proposed engagement, without the prior written consent of the other Party. Any public announcement so made, shall be as outlined in the Article 2 of this MOU.

6.6 License and Intellectual Property Rights

6.6.1. No license is granted under this MOU to either Party under any of the other Party's intellectual property rights, either expressly, by implication, inducement, estoppels or otherwise. Both Parties understand and acknowledge that grant of any such license shall always be expressed in writing.

6.6.2. Both parties will take all necessary steps to protect the knowledge documents and intellectual Properties generated during the process or shared by the parties.

6.7. Conflict of Interest

Neither of the parties believes that the Collaboration contemplated by this MOU raise any actual or potential conflicts of interest. The parties agree that this MOU and the negotiation of the same (and any other agreements entered into in connection herewith) are independent of any past, present or potential future arrangements, and are not connected to an existing business relationship between either of the parties.

ARTICLE 7: TERMINATION

7.1 This MOU shall also terminate without any liability to either party if otherwise agreed to by the Parties in writing with a notice period of 1 month.

7.2 Survival and binding Nature

- 7.2.1. Except for Clause 6 (Terms), Cause 7 (Termination) and 9 (Dispute Settlement) of this MOU, nothing contained in this MOU is intended to be or shall be construed in any way to be legally binding on any of the Parties.
- 7.2.2. Except as set forth elsewhere in this MOU, Clause 6 (Terms), Cause 7 (Termination), 9 (Dispute Settlement) shall survive the expiry or termination of this MOU.

ARTICLE 8: DISPUTE SETTLEMENT

8.1 Governing Law and Jurisdiction

- 8.1.1. This MOU shall be governed by and construed in accordance with the laws of Republic of Bharat. All disputes arising out of or related to this MOU, including without limitation all matters connected with its performance, will be governed by and construed and interpreted under the laws of Bharat, without reference to conflict of laws principles.
- 8.1.2. All disputes and differences arising out of or in connection with this MOU shall be the first instance referred to arbitration by three (3) arbitrators, jointly appointed by Parties. The decision and award determined by such arbitration will be final and binding upon the Parties. The arbitration will be conducted in accordance with the Arbitration and Conciliation Act, 1996, as may be in force from time to time. The arbitration proceedings will be conducted in Hindi, English or any Bharatiya Language and the seat of arbitration will be New Delhi.





Memorandum of Understanding

This Memorandum of Understanding is made on the 30th day of May, 2023

Between

The Central Sanskrit University, Delhi, established under Central Sanskrit Universities Act, 2020 passed by the Parliament, hereinafter referred to as the CSU, represented by its Registrar or any of its officers authorised by the Vice Chancellor, CSU

And

The Maharaja Bir Bikram University, Agartala, established under the Maharaja Bir Bikram University Act, 2015 (Tripura Act No. 6 of 2015) passed by the State Legislature of Tripura hereinafter referred to as the MBBU, represented by its Principal/Registrar/Director/Dean/HOD/Vice Chancellor

This MOU witnesses as under-

1. Whereas the main objective of the CSU is to promote, develop, propagate disseminate and preserve Sanskrit in all its aspects through any accepted mode, including Sanskrit learning under its Non Formal Sanskrit Education (NFSE) activity.
2. And whereas for implementing its NFSE activity, the CSU makes collaborations with the Universities, Colleges, Institutions etc. desirous of promoting Sanskrit learning to its students/ staff and general public within its reach, through NFSE Centre along with other similar academic activities at their organisation.
3. And whereas, pursuant to the proposal submitted by Maharaja Bir Bikram University (MBBU), for running of NFSE Centre, the CSU intends to collaborate with it for opening of the NFSE Centre in its premises and sign the MOU therefore.
4. And whereas, the CSU will provide the following facilities, arrangements and material for conducting the prescribed courses in this NFSE Centre-
 - a. Trained Sanskrit Teacher.
 - b. Prescribed monthly remuneration to be paid by CSU. (In addition to his duties in the allotted Centre, he may be required to teach the learners at any other nearby Centre/Centres if required).
 - c. Reading material for the learners
 - d. Prescribed guidelines for NFSE
 - e. Conducting examination at the end of academic session and awarding certificate/diploma to the successful candidates.

5. And whereas, the CSU will undertake Sanskrit education for Certificate Course in Sanskrit Language and Diploma in Sanskrit language of the duration of one year each for the learners in NFSE Centre. Learners enrolled in the Centre will be required to deposit prescribed Registration fee to the CSU.
6. And whereas MBBU will provide the facilities and extend support as under-
 - a. Suitable arrangements for functioning of NFSE Centre, including seating arrangements, infrastructure, electricity etc.
 - b. Nominating a faculty member as authorised officer to coordinate functioning of the Centre. He will be required to ensure that the courses are conducted as per the provisions prescribed in the guidelines for NFSE.
 - c. Publicising the Sanskrit learning courses of CSU in non formal mode and also making arrangement of the same at its Centre.
7. And whereas MBB University and CSU will jointly endeavour to promote Indian Knowledge System in Sanskrit pedagogy and arousing awareness for ethnic harmony in North-Eastern India.
8. MBBU and CSU will mutually address the issues of promoting contents of Sanskrit literature in development research.
9. MBBU and CSU will promote each other to organize seminars, workshops and symposiums for promoting cultural affinity and harmonious society.
10. And whereas in any matter concerning the NFSE Centre or any issue arising in conducting the courses, the same will be resolved jointly by the authorised officers of CSU and MBBU.
11. This MOU will be valid initially for one academic session and may be extended mutually.

Memorandum of Understanding (MoU)

Between

University of Science and Technology Meghalaya (USTM)

And

Maharaja Bir Bikram University, Agartala, Tripura (MBB University)

This Memorandum of Understanding (MoU) is executed on this 23rd day of July of the year 2022.

1. Parties

University of Science and Technology, 9th Mile, Baridua, Meghalaya– as the First Party;

and

Maharaja Bir Bikram University, Agartala, Tripura – as the Second party;

Herein together refer to as “Exchanging Institutions” in agreement.

University of Science and Technology Meghalaya (Accredited “A” Grade by NAAC & NIRF Ranking among top 200 Universities in India) having its registered office at Techno City, 9th Mile, Baridua, Meghalaya, herein called “USTM” is established by an act of Legislative Assembly of Meghalaya State in 2008. The objective of USTM is to impart world class education exploring opportunities and talents of North East region thereby creating cutting edge research centre and build the knowledge Capital for societal development, USTM is an upcoming University with minimal resources and high ambition trying for academic excellence.

And

Sabyasachi Pasola

Maharaja Bir Bikram University (MBB University) is a State university herein called "MBB University" located at Agartala, Tripura, India. It was established in 2015 by the Government of Tripura through the Maharaja Bir Bikram University Act, 2015 (Tripura Act No. 6 of 2015) of State Legislature and is the first, and as of 2022 the only state university in the state of Tripura. The University envisions to provide quality research and innovation and multi disciplinary education with emphasis on skill development and employment. The objective of the University is to disseminate and advance knowledge by providing instructional and research facilities in such branches of learning as it may deem fit and by the example of its corporate life, and, in particular, to make special provisions for studies in tribal life and culture and for integrated courses of Humanities, Commerce and Science in the educational programmes of the University and take appropriate measures for promoting inter-disciplinary studies and research in the University. Being the highest and noblest seat of learning, the University shall provide active leadership in guiding education and promoting research work in various fields and shall also endeavour to promote study of vocational subjects with a view to providing employment opportunities to the students.

2. Purpose

The purpose of this MoU to create a framework within the participating Institutions to seek and enrich their instructional programs and promote global awareness among their students. The exchanging Institutions, after approval by their responsible authorities, agree to pursue this agreement for academic cooperation/collaborations.

- i) The purpose of this agreement is to facilitate and to enhance the academic cooperation between the Exchanging Institutions.
- ii) The Exchanging Institutions shall promote direct academic contact between their students as well as academic teaching staffs and technical specialties.

3. Modes of Collaborations

The Exchanging Institutions shall endeavor to promote collaboration in various areas through a broad range of strategies, which in the initial stages may include but not be limited to:

- i) Academic exchanges of students, faculty and technical specialties. Both institutions will share their faculty resources for discharging teaching and research activities as per norms of exchanging institutions.
- ii) The design of collaborative research projects, including the developmental of formal proposals for funding for such research.
- iii) Collaborative student projects, when feasible.
- iv) Collaborative applications for outside Extra mural funding, such as foundation or government grants.
- v) The exchange of students and professors for professional internships in regional enterprises
- vi) Any expenditure incurred through the joint programme will be born as per mutual agreements.

4. Activities in Support of Collaboration

The Exchanging Institutions recognize the importance of certain ancillary in support of these areas of research and the technical collaboration. Principal among them shall be:

- i) The regular exchange of relevant publications and information generated by each of the Exchanging Institutions.
- ii) Regular communication concerning technologies and curriculum that will enable and enhance the substantive areas of collaboration referred to within this document.

5. Conditions for Collaboration

All collaborative efforts are by mutual agreement and in no way shall one Exchanging Institutions obligate the other.

- i) Nothing in this agreement shall create binding obligations on one Exchanging Institution by the other. All activities must be mutually agreed upon prior to the activity.
- ii) All participation by faculty or students in any aspect of these activities shall be entirely voluntary.
- iii) The outcome of the participating institutions in the form of Research Publications, Inventions and Patents shall be jointly shared by the Exchanging Institutions.
- iv) In formal negotiations, the Exchanging Institutions shall be represented by the Registrar of MBB University and the Director of USTM or their designees.
- v) Regularly employed personnel, while involved in activities under the Agreement, shall remain subject to the rules and regulations of their home institution in all matters of employment and benefits.

6. Terms of the Agreement

This agreement shall become effective when the signatories representing both institutions have affixed their signatures, and shall be effective for a term of five years. The agreement is to be automatically renewed at the end of each five years terms, provided that neither institution gives written notice of the termination of this agreement to the other institution. This agreement may be revised with the mutual consent of both parties.




