ADMISSION NOTIFICATION AND GUIDELINES

Maharaja Bir Bikram University, Agartala invites fresh online application for filling up of **46 Nos. Vacant Seats (UR-17; ST- 19, SC- 10)** available in the MBB University Website (www.mbbuniversity.ac.in) for admission to **Integrated Master Degree (IMD) in Commerce** programme for the academic session 2021-2022. Online filling up of Application Forms and submission of the filled up Forms is scheduled from **October 02, 2021 to October 10, 2021**. The candidates are required to fill up the online form and submit the same by uploading the necessary documents, photograph and signature.

Programme:

IMD in Commerce : Duration: 10 Semesters [5 (Five) Years]

A. ELIGIBILITY CRITERIA FOR IMD COMMERCE:

(1) Any student passed H.S (+2) examination or its equivalent examination with at least four (4) subjects including English from any recognized Board/Council shall be eligible to apply for admission to the **IMD in Commerce programme** subject to availability of seats, provided that he/she has secured in the qualifying examination, at least with-

a) Forty percent (40%) marks in aggregate and forty-five percent (45%) marks in the subject in which he/she seeks admission.

OR

b) Thirty five percent (35%) marks in aggregate and fifty percent (50%) marks in the concerned subject in which he/she seeks admission.

(2) (a) Any one securing at least fifty percent (50%) marks in H.S (+2) examination or its equivalent in aggregate in Science/Arts shall be eligible to apply for admission to **IMD in Commerce**, subject to the fulfillment of any one of the below mentioned conditions:

(i) has secured at least forty percent (40%) marks in Mathematics at Madhyamik or its equivalent Examinations.

OR

(ii) must have passed H.S (+2) or equivalent examination with Mathematics.

OR

(iii) must have passed two Commerce papers namely Accountancy and Business Studies in H.S (+2) or equivalent examination. However, a student who passed Accountancy in compartmental examination shall not be eligible for seeking admission to IMD in Commerce.

However, mere possession of 'Eligibility Criteria' does not entitle right to anyone to get admission to any programme under Maharaja Bir Bikram University. Regarding selection of Eligible Candidates for admission, decision of the Admission Committee shall be final.

C. Guidelines for Preparation of Merit List and Selection Procedure

CALCULATION OF SCORES OF EACH CANDIDATE

For Admission to IMD Programme

The merit list will be prepared according to the merit position to be determined after calculating the marks / Grade points /score in the following manner:

The percentage of marks / grade point / CGPA obtained in the Higher Secondary (H.S.+2) Examinations of the candidates who have successfully completed Higher Secondary Examinations and fulfill eligibility criteria as mentioned in point 'A' shall be considered for admission.

If the secured marks of two or more Candidates are equal i.e. if there is a tie, then the following steps shall be followed one after another to break the ties:

- a. Marks obtained by the Candidate in the Higher Secondary Examination in the concerned subject (subject in which candidate applied for admission) shall be taken into account and the candidate who has secured more marks shall be given preference.
- b. If the Marks in the concerned subject (subject in which candidate applied for admission) in the Higher Secondary Examination is also same, then the Marks obtained in the Matriculation Examination shall be taken into account and the candidate who has secured more marks in aggregate shall be given preference.
- c. If the Marks in the Matriculation Examination are also same, then the Date of Birth of the Candidates shall be taken into account and the senior candidate shall be given preference.
- d. If the Date of Birth is also same, then the tie will be broken by listing the name of the Candidates Alphabetically.

[If step (a) fails, step (b) would be followed; if steps (a) and (b) both fail, step (c) would be followed; if steps (a), (b) & (c) fail, step (d) would be followed.]

E. COUNSELING AND PROVISIONAL ADMISSION:

1. Given the pandemic situation the University shall conduct online provisional admission of Students on the basis of the merit list prepared following the reservation policy of Government of Tripura on a notified Date and Time. The selected candidates shall send an Admission Declaration Form along with relevant documents in the E-mail IDs provided by the University within the due date and time.
2. Students are required to submit self-attested photocopies of academic testimonials as well as all other documents including photo as per instruction of the University.
3. Student will have to take provisional admission on the notified Date and Time of Counseling by depositing requisite admission fee as determined by the University, failing which their Candidature

will automatically be treated as cancelled and the vacant seats shall be filled up from the waiting list in the order of merit.

F. RESERVATION:

As per existing reservation policy of the Government of Tripura, the available reserved seats shall be distributed among the reserved category candidates.

G. SUBMISSION OF APPLICATION FORMS:

The candidates need to fill up the online application form available in the University Website (www.mbbuniversity.ac.in) and upload necessary documents and photograph. The requisite **Application Fee of Rs. 300/- (for General Candidates) and Rs. 150/- (for SC/ST/PWD Candidates)** is to be deposited by the candidates in the following Bank Account and upload the payment details before filling up of the online Application Form for admission:

2. Candidates are required to fill carefully all details in the prescribed online application form without making any spelling mistakes.
3. No forms will be accepted after **October 10, 2021**.
4. Applicants are required to upload the following documents in jpg/pdf format:
 - One recent Passport Size Photograph.
 - Signature of the Applicant.

- Matriculation examinations Admit Card for age verification.
 - Matriculation Marksheet (both sides).
 - Higher Secondary Marksheet (both sides).
 - SC/ST Certificate issued by the competent authority.
 - PWD (Person with Disability) Certificate issued by the competent authority.
 - Proof of Nationality.
5. If any applicant has multiple mark sheets for any year, he/she is required to upload all Mark sheets (both sides) making one PDF file, i.e. First mark sheet, then it's back side followed by the Second mark sheet with its back side. Follow the same process if one has more mark sheets for the same examinations.
6. Please note that:
- Only one Application Form should be submitted for one course/programme.
 - Submission of Multiple Application Forms for one course/programme is strictly prohibited.
 - Separate Application Form should be submitted for separate course/programme.
7. Maharaja Bir Bikram University reserves all rights to change this notification at any point of time.
8. In all issues relating to the Admission Process for the Academic Session 2021-2022, decision of the Maharaja Bir Bikram University shall be final.
